You elected us with a clear mandate of no concessions; preserve letter 22, improve pensions, wages and save Jobs. Since, the first day that we faced the company the battle cry was the same. All for One an One for all no member will be left behind. It was a difficult job and we gave it all we had, but It was you, brothers and Sisters, courageous IAM members that achieved the GOAL.

It was all of you that left your work stations and joined in the Acts of Protest and repudiation to the Company's offers, it was the marches, the whistle blowing and all that wonderful noise, at all hours of the day and night, until the company realize that you meant business.

You showed the Company the solidarity in our struggle, the determination of the members for a fair and decent Contract.

It paid off; you deserve the credit, we were only the messengers.

Last Sunday close to 93% of the members in attendance, votes "YES" to ratify the contract, the numbers were:

2.609 = YES198 = NO 6 = VOID

They spent the morning with a group of people that held the line standing tall shoulder to shoulder, eye to eye with Corporate Greed; and Corporate Greed Blinked First.

clothes to wear, toys to play, a roof over your heads; and a Union Job to sustain them.

## A <u>**TURNBACK</u>** AND A REALLY BIG "AWWW, S --T" FOR P&W!!</u>

P&W, the "Company with A Heart" really doesn't care that much about it's employees apparently. Last month I wrote about the fact that the company was NOT living up to its responsibility by informing you of the drug testing changes. Seems they don't feel it is their responsibility to do so even though it is part of the federal mandate. With their strong belief in their ACE program, someone needs to prod the right people into doing their job! You could find out quicker by calling Sikorsky Aircraft where they do inform their employees. Don't worry though; I am sure they will be happy to inform you if you have any testing problems or a failure.

If you are involved in the FAA/DOT drug and alcohol testing program, I recommend you call medical and ask them about the changes such as testing for heroin and ecstasy; the lowered threshold levels for cocaine and amphetamines. Seems as though someone at Pratt should take responsibility in providing information on their drug testing program. (This is not the Union testing program). It is their responsibility, and "the right thing to do"!

Also of note, for those of you that are familiar with synthetic marijuana, also know as K2:

In the Federal Register, Drug Enforcement Administration (DEA) issued a notice of intent to temporarily add five synthetic cannabinoids to Schedule I of the Controlled Substances Act, as an "imminent hazard to the public safety". This ruling will make it illegal for K2 to be sold anywhere in the U.S. The manufacture, distribution, possession, importation and exportation of synthetic cannabinoids would be subject to regulatory controls, and administrative, criminal, and civil sanctions. When, you ask? It appears that the order will be finalized as soon as it passes through legal channels, probably within the next thirty days or so.

As your union representative, I will do my best to keep you, the membership, informed on matters such as these. However, I get annoyed by a company that expects the union to do their job for them because their too busy with other nonsensical tasks. Step up to the plate Pratt, and do what is right!!!

### **KNOW YOUR LOCAL**



**Connecticut State Council of Machinists:** The State Council is the political arm of the IAM in Connecticut.

Working with its' affiliated District, Local Lodges and IAM Eastern Territory, the Council works to defend the interests of working families through the political process. The Council holds two conferences each year on a Saturday and Sunday, in January and June. All IAM Locals in Connecticut are entitled to Delegates based on the number of members in their Lodge. Local Lodge 1746 is entitled to 5 delegates.

**New England Conference of Machinists:** The New England Conference of Machinists is made up by Delegates from Maine, Vermont, New Hampshire, Massachusetts, Connecticut and Rhode Island. This conference meets one weekend each year to discuss trends with the companies that are represented and national legislation that affects

all of our members. Local Lodge 1746 is entitled to 3 delegates to this conference.

### Connecticut State AFL-CIO, Greater Hartford Labor Council and Greater New Haven Labor Council:

All three of these entities are made up of delegates from affiliated labor organizations throughout the state. Much like the Connecticut State Council of Machinists, these groups focus on the political agenda for jobs and the welfare of our members. The CT AFL-CIO holds at least one conference each year and is very active in lobbying for labor friendly legislation and participates in election campaigns throughout the state. The Greater Hartford Labor Council meets on the first Wednesday of each month at 6:30 pm, except in July and August. The Greater New Haven Labor Council has a delegate meeting every other month.
