As always he took every chance he got to spill his venom and lies to all of the employees coerced into attending the show. Of course there was no I.R. or H.R. or any

kind of upper management "R" so they could not be compelled to testify that they heard all his plans and misinformation first hand.

Let's start with, "We are working with the Union on all this". Nothing could be further from the truth. What he chose not to tell the people was that the Union has refused to make any side deals with him. The last letter 22 meeting was very short to say the least. The Union asked Smith, "Where is the data for all of the work is sent to Florida?".

When the Union objected to this mention of his new "Job Combo" and told him that he doesn't change or alter the contract at his will, he threatened the Union with vending out more work if we don't agree with his plans.



After those words, the union walked out of the meeting. Thisinformation, Brothers and sisters, he chose not to tell the workers at his all hands meeting. He must be following his superior's orders to dismantle the CAN as soon as possible and the real culprits are hiding their identities. Is it Mr. Wyman? Is it Upper H.R.? Who Knows?

He doesn't want to do sheet metal work anymore, so he doesn't need the 240's. He wants to train 176's to op-

erate new machines that weld, and do away with welders. He is preparing to dismantle the Chemical line and send it to Middletown and wants to pick and choose who moves with the work, never mind that he hasn't officially notified the Union of such a move as required in Article 27. He believes that by telling the employees on the shop floor and at his captive audience meetings

that he is off the hook. He is mastering the technique of surface bargaining. Mr. Smith and his minions con-

tinue to remove and refuse to bring back covered work under Letter 22 and vends out with excuses of machine

he vends out with excuses of machine breakdowns etc... He is not bringing anything back or replacing that work out with other types of work. He

has increased the work load going to Florida and he plans to increase the spray boothes in Florida from 6 to a total of 8, at our expense. Salary doing 901 work in the



CANMC continues at a rapid place, the company's answers to our concerns is their new and improved "Training Plans" for 901 to do the work that salary is doing. They have such a commitment to this training plan that they just laid off 3 salary training coordinators. They couldn't lay off the salary people doing that 901



job instead the Company got rid of the trainers that were instrumental to work with the Union training coordinators to write SAP system etc.

In the words of one of the Union training Coordinators, "We in East Hartford are dead in the water". So much for Letter 14 (technical training)! Talk about cutting the funding to a mandate!!! Mr. Smith doesn't care, he is above the Law, he does what he wants and if any H.R. or I.R. person wants to give a disposition on a grievance concerning his CAN Empire, they have to consult with him first. If they don't, he will reverse dispositions and do whatever he wants. Who is really in charge of East Hartford? It sure isn't H.R.

Brothers and sisters, we are in a war for survival. the corporation's main concern now is to finish the Goodrich Deal and they will do whatever is necessary to achieve it.
