Connecticut IAM Locals to Team with State Senators to Combat Substance Use Disorder in the Workplace

Last week, State Senator Dr. Saud Anwar (D-3) called on his union friends to join him at the State Capitol to support an announcement of a new initiative he was launching, an effort to declare Substance Use Disorder (SUD) as an Occupational Disease. Members from Locals 700, 743, and 1746, along with staff members of ConnectiCOSH and leaders from the CT AFL-CIO met with Senator Anwar and Senator Hochadel (D-13), both good friends of Labor.

Substance Use Disorder is defined as "the repeated use of alcohol or drugs that cause significant impairment in a person's life", per the Connecticut Network . Sen. Anwar described how sports injuries is one pathway to Opioid Use Disorder, which accounts for about 11% of all SUDs. Athletes seeking pain control from opioids for long-term or chronic injuries can ultimately fall into the clutches of heroin or fentanyl addiction which often leads to death. Dr. Anwar then drew a straight line between these kinds of tragedies and those that beset Connecticut workers who suffer from Repetitive Strain Injuries. The difference, which he points out, is that athletes have a choice—to quit playing the sport that ails them—but workers often do not have that choice.

Injured workers often start with over-the-counter pain medications such as Tylenol or Advil, or other types of non -steroidal anti-inflammatory drugs (NSAIDs). But these can cause high blood pressure, gastric ulcers, and other

side effects. The injured employee may graduate to opioids like oxycontin, which can provide greater relief but which are also highly addictive chemicals. When the opioids are cut off due to cost or terminations of prescription, the worker—who is now addicted to them—will seek other means of pain control such as heroin or fentanyl. Even if they don't die, their ability to perform their job is severely compromised; they may be demoted or fired for substandard performance, and then they are beset with mental anguish as well as well as the stigma of being a user. It's a vicious cycle that they can rarely break free from on their own, one that will ultimately lead to their destruction

Dr. Anwar asserts that when someone becomes addicted to opioids due to a workplace injury, it is an Occupational Disease. And it's preventable, because ergonomic interventions—workstation design, body positioning, training and education—can prevent the injury from occurring in the first place. Anwar believes that by recognizing SUDs as Occupational Diseases, we can have more open conversations about the problem, break down stigma, and compel companies to provide more impactful interventions, not only in the ergonomics arena but also in the human services arena, by recognizing when someone has fallen into addiction and treating them humanely by helping them on the path to recovery. We look forward to working with Senators Anwar and Hochadel in the spring of 2025 to help address this vitally important matter at the next legislative session.


