#### **Sisters and Brothers:**

While your Negotiating Committee was hard at work preparing for our upcoming negotiations, Pratt management implemented an unscheduled shutdown in the shop with less than a month's notice to the membership. This shut down will start on Thursday January 2<sup>nd</sup> through Sunday January 5<sup>th</sup> and then Saturday July 5<sup>th</sup> through Friday July 11<sup>th</sup>.

This doesn't make any sense. The company wants us to work lots of overtime up until the beginning of the year and then they reward us for our sacrifice with days without pay? Is this lack of respect what we can expect going forward? What's next? Will the company need us to then work OT when we get back on January 6<sup>th</sup>? These forced days off will be a huge burden for all our sisters and brothers and their families, especially those on the AWW shift because they will be losing a full weeks' pay. We should be working, not being punished for going the extra mile!

I have requested information from the company for the CT Shared Work Program outlined in Letter 24 of our contract. If the company's going to force us out, we should be able to utilize this program instead of using your vacation time and sick days. Just because they can't manage their business, they shouldn't expect us to ping pong at their whim. Our contract negotiations are starting very soon and this is a terrible way to start the year. Hopefully management doesn't follow Boeing's thoughtless decision-making process in April during negotiations.

Last week, your elected negotiating committee from East Hartford and Middletown met for a week at

William W Winpisinger Education Center (W3), the IAM's Union's training center in Hollywood, MD, for our upcoming contract negotiations in April. During the week we read every single survey that was turned in, created a strategic plan and drafted proposals. We set dates for the strike sanction vote, proposal meeting, the final week of negotiations and ratification vote. We also prepared the Negotiation Survival Handbook which will be available soon. Stay tuned.



If you are going to apply for a dues refund.... Please submit this application NO LATER THAN 60 DAYS FROM THE START OF YOUR ABSENCE in accordance with the I.A.M. Constitution (Pg. 124). Failure to do so will result in the refund request being denied.

The unemployment option works as follows: Members who are unemployed for the **major portion** of any month (the major portion of any month shall depend on the ma-

Members need to let us know within 60 days of being out and then they need to let us know when they return to work. If they don't adhere to the constitution then unfortunately their request will be denied.

The company currently has over \$100 Billion in back orders. Yet, they believe that this is a good time to lock us out?

Pratt should be careful of what they wish for! Come May 2025, if we are unable to achieve our goals, then January 3<sup>rd</sup> will go down as training day!!
